

Procedures for Student visa at BICC

BICC is the only private Chinese school in Beijing authorized to issue JW202 form required for student visa (short-term X2 visa, long-term X1 visa).

Documents needed:

- Application form dully filled
- Copy of passport
- Registration fee: 650RMB
- Tuition fee

Once we received the documents at info@hibicc.com and the fees, we will issue the admission letter and JW202 form.

JW202 is a form required by Chinese consulate in order to provide a student visa. The Ministry of Education (MOE) prints JW202 form. It takes about 10 – 12 days to get the JW202 from the MOE.

How to apply from Overseas:

MUST apply at least 30 days before the course start date (sometimes from 30 to 50 days)

Once you decide the course style and course lenth, you will have 2 options:

- 1) You register for a course at BICC website (www.hibicc.com), student can click on apply online button on the top right corner to begin the application process. Once the application is successfully submitted, BICC system will send an invoice.
- 2) You send us an email at info@hibiccc.com and we will give you all the procedures.

100% of the tuition must be made in order to start the visa process.

On confirmation of student's payment, BICC will apply for JW202 form.

BICC will send the JW202 form to student's address in his/her country. Student applies for student's visa with the JW202 form at the Chinese embassy.

- Student will get X2 visa if his/her course duration is less than 180days.
- Students with course duration over 180 days will get a temporary visa which BICC will convert in residence permit on student`s arrival in China.

Process for converting Temporary Visa into Residence Permit:

1) Health check from China Inspection and Quarantine.

2) Four 2 inch pictures

3) Police Housing Registration.

* Student should visit China inspection and Quarantine to obtain his/her health check.

Please have the BICC address with you when you go for the health check-up, BICC Sanlitun campus is the address of delivery for the health check report.

Once the medical report is received (after 3-4 days) BICC will apply for student`s residence permit. Below is the cost for changing temporary visa into residence permit.

X1 (Residence Permit in China): Course duration above 180 days.

Less than 365 days (all countries): 500RMB

How to apply from China:

MUST apply 21 days before the visa expire date.

100% of the tuition must be made in order to start the visa process.

After making the payment student must visit BICC with the following documents:

- 1) Police Housing Registration
- 2) Four 2 inch pictures
- 3) Passport with at least 6 months validity and 2 free pages.
- 4) Health Check (only for students with course duration over 180 days).

Student will get X2 visa if his/her course duration is less than 180days.

Student will get X1 visa if his/her course duration is over 180days.
